Newton Community and Local Government Update

Good Morning Newton Residents,

I hope you and your families are well.

This week, the number of COVID-19 cases in Newton has increased to 749 as of May 28th and the number of reported deaths has risen to 107. While Newton's numbers are going down (see <u>Jack Prior's analysis</u>), we know that COVID-19 has had a tremendous impact on our vulnerable populations. Here in Newton, it is our senior care facilities that have been hit hard - see the State's <u>Weekly Public Health</u> <u>Report</u>.

Outside of our bubble, communities of color have been disproportionately impacted by the virus. Now, as I write this, protests are erupting throughout the nation, as we grieve and mourn the senseless deaths of George Floyd, Breonna Taylor, and Ahmaud Arbery, and face the racial disparities. injustices, and flat out racism, that confront our black and brown communities. In a time when we are advised to stay-athome to be safe from the pandemic, racial injustice has forced us out of our homes and into the streets to demand justice. As we move forward, remember to protest safely, learn more about these issues, and support these targeted communities.

# What's Up in Newton this Week? COVID-19 cases continue to rise; Newton Police and Residents respond to racism and death of George Floyd, Council invites Former School Committee Chair, Matt Hills to discuss the state of current school finances, and more....

**COVID-19**: The number of confirmed cases in Newton continue to rise – slowly, but still rising. The current case number is 749 and the total number of deaths has risen to 107. While nursing home and elder care confirmed case numbers and deaths are available from the state, the City has not published that data to date, on its website. That data can be found <u>here</u>.

**Re-opening in Newton continues**: Last week, I reported that Newton was slowly beginning to open – with the opening of Newton Parks and Recreation Tennis Courts and the Recycling Center (by appointment only beginning on June 2nd). City Hall will begin opening up to the public by appointment only beginning on Monday, June 15th with full opening scheduled for Monday, July 6th with physical distancing and face coverings required.

**Congratulations to Newton North and Newton South Seniors**: If you have been out and about in your neighborhood, you may have seen signs all across the City celebrating the senior classes of Newton North and Newton South on their graduation!

#### Newton Responds to the Death of George Floyd and racism:

The Newton Police Department took to Twitter regarding the actions of Minneapolis police involved in the death of George Floyd: "Chief David MacDonald and the Newton Police Department condemn the unacceptable actions of Minneapolis police officers that led to the death of Mr. George Floyd. Our heartfelt condolences go to his family and friends."
